GENERAL DEFINITIONS AND EXPLANATIONS

Carcass weight or slaughter weight of a bovine animal — the weight of a slaughtered bovine animal's cold body after having been skinned, bled and eviscerated, after removal of the genital organs with the attached muscles and the udder and the mammary fat, after the feet have been severed at the carpametacarpal or tarsometatarsal joints and the removal of the head.

Carcass weight or slaughter weight of pigs — the weight of a slaughtered pig's cold body after having been bled and eviscerated and after

the removal of kidneys and flare fat, the bristles, the genital organs, the tongue, the diaphram and the hooves.

Carcass weight or slaughter weight of sheep and goats — the weight of a slaughtered sheep's or goat's cold body after having been skinned, bled and eviscerated (except the kidneys, kidney fats), and after the removal of the head (separated at the atloido-occipital joint), the feet (severed at the carpo-metacarpal or tarsometatarsal joints), the tail (severed between the sixth and seventh caudal vertebrae) and the genital organs (including the udder).

eSTAT (https://estat.stat.ee/) is for data submission.
