Please double-check the fields of prefilled columns (1, 2, and 4) and correct and fill in the price fields where necessary. If a prefilled service is no longer supplied, note in column 3 "Remark" that the service has been discontinued and add a new service on an empty row and the service code in field A. In case of renting out own real estate (EMTAK 682), indicate the ratios of rental income and expenditures to square metres of rented real estate.
